Oral History Deed of Gift

By this Agreement, the "Donor", or narrator of the interview, gives to the Lynchburg Museum System (hereafter known as the LMS) all of the Donor's right, title and interest, including the copyright and intellectual property rights in the "Work", and the LMS accepts Donor's gift of the Work, subject and according to the following terms and conditions:

- 1. Donor represents and warrants that s/he owns and has full title to the Work, and is legally authorized to enter into this Agreement and to give the Work to the LMS, that s/he needs no approvals, consents or agreements of or from any other third party, and that there is no lien, encumbrance, security interest, or other interest or claim of any third party in or to the Work.
- 2. The LMS represents and warrants that it has the full power and authority to enter into this Agreement.
- 3. The LMS will organize, process, conserve, and provide access to the Work in accordance with accepted professional standards and best practices and with the LMS's policies and procedures. In accordance with the LMS's policy, and the intent of both the LMS and the Donor, the Work, once organized and processed as available for use, will be open to all researchers, regardless of affiliation or other considerations.
- 4. Donor's grant to the LMS includes the copyright and all intellectual property rights, which encompass the right to edit and publish the Work. Donor reserves the right, and the LMS hereby grants to Donor, the nonexclusive right to copy, and publish the Work, to create new works based on the stories and concepts contained in the Work, and to otherwise use the Work in part or in full until Donor's death, provided, however, that where the Donor creates derivatives of the Work, s/he will provide notice to LMS of having done so.
- 5. This Agreement constitutes the entire agreement between the parties with respect to the Donor's gift of the Work to the LMS and supersedes all prior agreements and understanding between Donor and the LMS, whether written or oral, with respect to such gift. This Agreement is binding on and shall inure to the benefit of the LMS, its successors and assigns, and upon the Donor, his/her representatives, executors, heirs, successors, and assigns. This Agreement may not be modified or amended except by a writing duly executed by both parties.
